LIUNA CONVENTION 2026

The LIUNA Convention is set to take place September 21-24, 2026, in Las Vegas, NV. Local 305 qualifies to send eleven delegates to the convention. President Jackson, by virtue of her position, is automatically appointed as a delegate, leaving ten spots to be filled. A nomination meeting to select candidates to run for the other ten delegate positions will take place on May 22, 2026. LIUNA will be covering the cost of a 4-night hotel stay, per diem set at \$1,000 (\$250 per day), breakfast, and transportation/airfare to Las Vegas. The Local Office shall reimburse for lost time, provide shirts for the convention, and give an additional \$120 per diem allowance to the elected delegates. Treasurer Robinson provided the Board with a budget breakdown outlining the maximum cost the Local Office could incur. As such the following motion was made:

Motion: *DCSEBM Demetria Spratley moved to accept the budget of approximately \$17,374 for the LIUNA Delegate Convention. Seconded by NCSEBM Cynthia Brown and passed by unanimous roll call vote.*

SAMLU

The second SAMLU of 2026 is set to take place August 17-19 in Minneapolis, MN. The Board will travel on August 16 & 20. Treasurer Robinson provided the Board with a budget breakdown outlining the maximum cost the Local Office could incur for the event. As such the following motion was made:

Motion: *NCSEBM Cynthia Brown moved to accept the budget of approximately \$33,000 for the SAMLU in Minneapolis, MN. Seconded by DCSEBM Demetria Spratley and passed by unanimous roll call vote.*
